What is the statutory inspection of septic tanks?

It is an inspection to confirm that the septic tank is working properly and performing its primary function.

Through this inspection, it is possible to determine that the water coming out from septic tanks of homes and business establishments is clean and environmentally friendly.

According to the Purification Tank Act, it is mandatory to undergo statutory inspection by a designated inspection agency once a year, in addition to maintenance and cleaning.

Statutory Inspection | Designated Inspection Agency

- Regular maintenance and cleaning implementation status and septic tank operation status

- Results of inspection will be provided to the septic tank management company as well as the administrative agency.
- Frequency: once a year
- Statutory inspection can only be performed by a designated inspection agency.

* What is BOD?

Biochemical oxygen demand (BOD) is an index that measures the degree of pollution of wastewater from septic tanks.

The lower the value, the cleaner the water.

• What happens if the BOD value is high?

This indicates that the water coming out of the septic tank is dirty. This would cause red tide and blue-green algae, and adversely affect the environment.



Frequently Asked Questions (FAQ)

- Is it possible for maintenance service providers to conduct the statutory inspection?
- A No. The statutory inspection can only be conducted by an inspection agency designated by Shizuoka Prefecture.

People conducting the statutory inspection need to ensure reliability, fairness and consistency of the inspection. Hence, prefectural governors are mandated by law to designate an inspection agency.

In Shizuoka Prefecture, the "General Incorporated Foundation Shizuoka Chemical Analysis Center" is the designated inspection agency authorized to conduct statutory inspections.

- What should I do if the statutory inspection result is not satisfactory?
- A Please consult with contracted companies dealing with septic tanks and take appropriate measures.

The inspection result submitted by the designated inspection agency has three levels of evaluation: "a. Acceptable", "b. Generally acceptable", and "c. Unacceptable".

If you receive a "c. Unacceptable" evaluation, you may be in violation of the standards set by law. Please consult the appropriate septic tank service provider (cleaning service, maintenance service, septic tank construction company), who can address the evaluation result and take appropriate action.

- What happens if I do not undergo the statutory inspection?
- A The prefectural government will issue instructions and mandate an inspection. A Prefectural Health and Welfare Center staff will visit you and give instructions.

The statutory inspection is very important in confirming that the septic tank is being maintained properly and its original purification function is working sufficiently.

As mandated by law, the Prefectural Health and Welfare Center will issue instructions if you persistently refuse inspection. In addition, you may be subject to pay penalties up to 300,000 yen. Hence, make sure that you undergo the inspection.
